CHAPTER ONE: NICA

De Netherlands Institute for Cultural Analysis (NICA) is dedicated to **Cultural Studies/Cultural Analysis**. The field is not defined by a particular type, medium, or genre of objects. Cultural Studies investigates contemporary socio-cultural objects, phenomena, and developments from a broadly hermeneutic, critical, theoretical, and interdisciplinary perspective. The field cuts across different disciplines, such as Comparative Literature, Media Studies, Art History, Theatre and Performance Studies, Sociology, Communication Studies, and others.

The **goals** of the School are as follows:

- Facilitating a **national graduate environment**, in which staff researchers, PhD candidates, and research-master students meet and interact. As a national school, we strive to introduce our members to an extended intellectual community, open up research perspectives beyond local priorities, and advance the sharing of resources and expertise. Following this aim, we observe no rigid boundaries between activities for PhD fellows and research-master students (though different emphases certainly apply);
- Organizing activities that map and analyze **the present** — including the deployment of the past within the present (cultural memory, cultural heritage). We'd like our activities to reflect current research priorities, and to propose new tools and concepts to gain critical purchase on contemporary circumstances that are changed and changing;
- Fostering **international dialogue**;
- Opening out to social and political **partners outside the academy**. We want to enable intensified contact between academics and various parties working outside the university: professionals, intellectuals, curators, organizers, activists, artists, journalists, writers;
- Cultivating a light and **non-hierarchical organization**, hospitable to varied initiatives. We prefer informal dialogue over protocols and procedures. Both PhD fellows and research-master students are very welcome to initiate activities of their own. In principle, our activities are open to all.

In the past few years, NICA has not generated the number of ECTSs that the Regieorgaan requires for its **funding benchmark**; accordingly, our budget has been reduced. The leading cause for this is plain: affiliated programs have implemented the 10-ECTS requirement in varying ways. As a result, many of our research-master students don't actually have an obligation to follow 10 ECTS of modules at NICA. To respect the autonomy and diversity of participating programs, we have decided not to force our member students to earn 10 ECTS with us. In addition, we allow member students to obtain credits at the other schools as well, should that be their preference.

At the same time, the large numbers of student members (168), some *with* formal requirements, require us to offer a regular **core curriculum**. At present, we program four modules in total: three courses are contributed by UvA (6 ECTS each); one by Utrecht (5 ECTS). (In 2021, Leiden University will start contributing a sixth course, Digital Media and Machinic Cultures, of 10 ECTS). Throughout the year, we offer many other seminars, workshops, and events, most with attached ETCS, but our core curriculum remains relatively constant and enables students to plan their study paths in advance. All of our courses are presently over-enrolled; we work with **waiting lists** for all. Having said that, it's also clear that students don't always pass the courses in which they participate; this year's numbers vary from 9 to 29 ECTS-earning students per course.

All of our core courses are offered by the School, so they're not embedded in existing programs. This is so because the graduate courses of the main and most actively participating programs are already at capacity. At times, the VU has opened up one of their courses for NICA students. Since skills courses are frequently offered by the local graduate schools, all of our courses are **contents- and methodology-based**. All courses are interdisciplinary in nature, including a variety of objects, methods, and theories from the broader field of Cultural Studies. The courses are distributed throughout the academic year. A quick overview is below.

CHAPTER 5: REFLECTION

After two consecutive periods — that is to say, ten years in total — NICA’s time at the University of Amsterdam has come to an end. As of January 2021, the school has found a **new host** in Leiden University, a new managing team — led by academic director Pepita Hesselberth — and an entirely new advisory board. The transition has been all but seamless, and NICA has continued and intensified its activities from day one. We could not have hoped for a better new home and a better team. We are exceedingly grateful for all parties involved in this transition of the school — the two Faculty deans in particular — and we fully trust that the new NICA will continue the best the school has had to offer while, at the same time, renewing and broadening its offerings. We wish Pepita, Kim, and Tessa great success.

Looking back at the prior period, we cannot but acknowledge that it has not always been easy for us to secure sufficient core courses for the research-master students in our affiliated programs. Nevertheless, the situation improved towards the end of the period, with Leiden University and Utrecht University currently contributing modules, adding to the three modules our host Faculty has graciously facilitated. Now that the school has moved to Leiden, we would hope that our current **course offerings** will be retained and, if possible, expanded with contributions by the other participating Faculties. This aspect of NICA’s functioning will require ongoing attention from participating institutions and their administrations.

Additionally, the agreement reached between Logos and DLG, specifying that all research- master students must follow 10 EC of course work at the national schools, remains implemented in different ways and to different degrees at the affiliated programs (for instance, at the University of Amsterdam, research-master students are required to take 6 EC at the national schools). This flexibility would not be much of a problem, if not for the fact that NICA’s financing partly depends on member students fulfilling said requirement. This tension between agreeable flexibility and strict financial incentives requires **further finetuning** in the future.

The financing of PhD candidates has seen a fundamental change over the last years. A considerable number of our PhD members used to be financed internally, i.e., by our participating institutions; now, approximately half of our PhD fellows are, for want of a better term, **self-funded or independently funded**. Positions obtained from the NWO Promoties in de Geesteswetenschappen and project financing remain inevitably piecemeal and irregular. NICA has always admitted non-financed PhD candidates to its activities without reserve and, more importantly, without requiring a fee. However, most faculties remain hesitant in formally signing up external PhD candidates with the national schools. In the interest of an active and thriving national PhD community for the field, it would be advisable to recognize both financed and non-financed candidates equally. The peer support such a national community can foster is a precious resource.

For the **upcoming years**, NICA’s priorities will be:

- to update and modernize the School’s website and newsletter;
- to revitalize the research-master student and PhD councils;
- to try to achieve a more even distribution of course courses across participating institutions, including closer cooperation *between* institutions;
- and to connect NICA with international networks in Cultural Studies.
